Hair Styling Coach Levon Holman's Booking Agreement

Upon valuable consideration and mutual promises, the persons named below as "Producer and Hairstyling Technician" hereby covenant and agree to be bound to the following as their BOOKING "Agreement" for Hair Styling Coaching with Levon Holman, a general VENTURE governed by the laws of the State of Virginia (hereinafter known as "the Joint Venture") dated this ___ day of _____, 2009 for Hair Styling Coaching with Levon Holman.

Section 1.01. The below terms are to have the following meaning when used in this agreement: "Agreement" shall mean this Booking Agreement, from _____, 2009 to _____, 2009.

I, _____ (Producer), hereby acknowledge that I must pay for the following in order to book a seminar or class with Levon Holman:

- Total cost of round trip airline ticket, both baggage fees, \$15 per day for meals, all cost to get to and from airport and hotel and hotel accommodations. (If a Flight is required).
- Total gas cost of round trip travel, hotel accommodations. (If self driving is required).
- \$800 per day or \$800 per seminar/class (Forms of payment: All Major Credit cards, Cashier Checks, Cash and Absolutely No Checks).
- 50% of the total cost per day or seminar/class is due upon signing this agreement however if the seminar/class is canceled the 50% of the total cost will be refunded or credited for future reschedule dates

I, _____ (Producer), hereby acknowledge that in the case of any unforeseen need to cancel seminar/class that I will be totally responsible for posting a reschedule date as well as refunding all monies to those who request it (this will not fall on Levon Holman as a responsibility). I also acknowledge that if Levon Holman's Flight arrangements or car travel cost have already been paid for and He is present to do my seminar/class and the seminar/class is canceled that Levon Holman will not be responsible for paying me for those flight arrangements and Levon must still be paid for his travel cost. However, Levon Holman will agree to set another reschedule date under the same above terms.
